Carer Payments Examples

Example 1

Sally is a general foster carer currently caring for two children, Jack (6 years of age) and Emma (3 years of age).

Sally's ongoing fortnightly carer payments would be:

The fortnightly carer payment is a reimbursement to help cover the day-to-day costs of caring for a child or young person. For example, a carer may wish to use the payment to assist with expenses such as food, clothing, recreation, entertainment, basic medical costs, travel etc.

Example 2

Start-up Placement

Peter is a kinship carer and his niece Isabella has just entered his care. Isabella is 14 years old. Peter will receive an initial start-up payment of \$177 within the first 48 hours of the placement commencing and then the ongoing fortnightly base rate for Isabella. Isabella has special needs and has been assessed to receive a Special Needs Loading (SNL) of 150% in addition to the base payment.

Peter will receive within 48 hours:

Placement start-up payment \$177.00

Peter's ongoing fortnightly payments would be:

Base Rate \$716.40 SNL 150% \$593.70*

Total Fortnightly Amount \$1,310.10

Peter may also be entitled to the following additional periodic payments:

Education grant** \$274.00 Activity grant*** \$106.00

Christmas and Birthday Presents

Carers are expected to provide a gift for special events, birthdays and special parties for the child when they occur. This should be covered by the fortnightly carer payment. The case manager will also purchase a birthday and Christmas present for the child. DCP may contribute towards the cost of gifts from the child to birth parents or sibling where assessed as being necessary particularly during reunification. This is assessed on a case by case basis.
